
I am citizen of India and seeks the following information under Section 6(3) of RTI Act, 2005.

1. Please provide copies of compliance report/communications/letters/comments of both REC Ltd. and PFC Ltd. in compliance of Presidential Directives regarding pay revision of Board and below Board level executives in REC Limited issued by Ministry of Power (MoP) vide letter Ref. No. 46/8/2017-RE Dated 10th May, 2018.
2. Please provide copies of compliance report/response of REC Ltd. and PFC Ltd. by providing justification to directions of Ministry of Power letters dated 20.06.2018, 28.11.2018, 09.01.2019, 28.01.2019, 15.02.2019, 26.02.2019 and 10.04.2019 in compliance of Presidential Directives regarding pay revision of Board and below Board level executives in REC Limited and DPE Guidelines Dated 10th May, 2018.
3. Please also provide the copies of clarifications from all CPSUs including REC Ltd., and PFC Ltd. under MoP to Ministry of Power's Office Memorandum No.46/8/2017-RE dated 09.01.2019 and 28.11.2018 regarding following queries of MoP:
 - (i) Whether executives with three different designations have been still included in the single pay scale in E-8 Grade? Please provide copies/notings/letters/comments of the same as per record of MoP.
 - (ii) Whether all the employees of the Corporation in the Grade E-8, irrespective of their designations, are given, uniform and fair opportunity for promotion to the next grade of E-9 category or higher grade on deputation, without any discrimination?. Please provide copies/notings/letters/ comments of the same as per record of MoP
 - (iii) Is the fringe benefits (perks & perquisites) to thee 3 Designations is same. If not, explain why the emoluments are not uniform when the grade is same. Please provide copies/notings/letters/comments of the same as per record of MoP.
 - (iv) Criteria for upgradation of designation/re-designation from DGM (Grade E-8) to AGM (Grade E-8) and AGM (Grade E-8) to GM (Grade E-8) in the same pay scales of Rs.51,300-3%-73,000 (Revised now Rs.1,20,000-3%-2,80,000). Please provide copies/notings/letters/ comments of the same as per record of MoP.

Please furnish the above information u/s 6(3) of RTI Act, 2005 at the earliest possible within 30 days from the date of issue of this application. If the above information does not pertain to your department, you can forward this RTI application to the concerned department/office under section 6(3) of the RTI Act, 2005 to obtain the desired information as stated above.
