5. Please provide me with the details regarding the qualifying marks (in Part A & Part B or on aggregate) in written exam of DPC exam -2018 from S4/SG to E2.

Reply: The qualifying marks in DPC written test is 50% for General and 40% for SC/ST category in aggregate of Part A & Part B.

6. Please provide me with the details regarding the qualifying marks (in Part A & Part B or on aggregate) in written exam of DPC exam -2019 from S4/SG to E2.

Reply: Reply to the above query is already been given in point no.5.

7. Please provide me with the details regarding the instructions were given to evaluators for evaluation in written exam for DPC exam -2018 /2019.

Reply: No instruction, other than to evaluate the papers as discreet and as soon as possible were given to evaluators.

8. Please provide me with the details regarding whether the POWERGRID inform in written to the eligible candidates about qualifying marks before commencement of DPC exam 2018/2019 for scoring in Part A and Part B or in total.

Reply: No, POWERGRID does not inform in written to eligible candidates about qualifying marks, as it is already mentioned in Policy manual.

9. Please provide me with the details regarding the Policy/ Manual copy of POWERGRID wherein it is mentioned about qualifying marks in written exam of DPC.

Reply: Copy of Company Policy regarding Promotion of employees in Supervisory category is enclosed at **Annexure -II**

10. Please provide me with the details regarding whether the POWERGIRD conduct DPC exam every year on time like CPC is conducted timely? If yes, then furnish the copies in support of it. If not, then kindly provide me with reason.

Reply: Yes DPC is conducted for each year. However, sometimes Written Test for two consecutive years were conducted together.

11. Please provide me with the details regarding the result of DPC-2019 (of written exam) had not been announced by ER1 on website of POWERGRID. Then, whether someone leaked such a very confidential matter through whatsapp in ER1. Please provide the name of such person.

Reply: The query sought is outside the purview of "information" defined under section 2(f) of RTI Act, 2005.

12. Please provide me with the details regarding the result has not been announced by ER1 of candidates who qualified in written, then the result declared in the whatsapp that is viral is whether authentic or not. If the result is not authentic then whether the management of ER1 had taken any steps to stop it. If yes then kindly furnish me the details of the process, if no then kindly furnish the reason for the same.

Reply: The query sought is outside the purview of "information" defined under section 2(f) of RTI Act, 2005.

13. Please provide me with the details regarding the marks obtained by the qualified candidates in written exam of DPC 2019 of ER1 of POWERGRID as per given below.
- a. Marks obtained in Part A and Part B by each qualified candidate
  - b. Total marks obtained in aggregate i.e. out of 100 by each qualified candidate. Kindly provide me the details along with all the information under RTI Act 2005. As per section 6(3) of the RTI Act 2005, in case the requested information is held by another public authority, I request the PIO to transfer the application or part of it within 5 days and immediately inform me about such transfer. As per Section 7(8)(3) and 7(3) (2) of the RTI Act 2005 I request the PIO to inform me of the particulars of the First Appellate authority.

Reply: The details regarding the marks obtained by qualified candidates pertains to third party information, disclosure of which does not serve any public interest. Accordingly, as per section 8 (d) and 8(j) of the RTI Act the information sought cannot be provided.
