Compilation of such voluminous data would disproportionately divert the resources of the organisation and is therefore avoided under section 7(9) of RTI act. Moreover, the desired information pertains to third party and cannot be provided under section 8(1) of RTI act. 1st Appeal: The requested data is only regarding the staff having disabled children and not of all the staff, which may be very limited in number. This may not be voluminous data. I never sought personal particulars of any individuals like name, address, cadre etc., or any other identity related information. The requested data is having public interest, as all the payments made are from the PSU/public funds only. Hence I appeal to provide the requested data. 2. Information sought:: No. of employees presently in executive cadre - - - may please be provided separately. Reply Received: Reply2)-Data in form requested is not readily maintained. Further, creation of such voluminous data would disproportionately divert the resources of the organisation and is therefore avoided under section 7(9) of RTI act.
