**ORDER**

**Grounds of Appeal:**

Being aggrieved by the information provided by the CPIO, POWERGRID, SR-I, Secunderabad, vide his letter No.SRTS-I:RTI-120:3011:2020 Dt: 05.05.2020 against the Request of the Appellant vide on-line application No. PGCIL/R/E/20/00142 Dt: 12.04.2020, the Appellant has filed this on the following grounds:-

The Appellant has stated that CPIO Office had not provided the requested information for the RTI Request Ref.No. PGCIL/R/E/20/00142 Dt: 12.04.2020.

On receipt of the Appeal PGCIL/A/E/20/00022 Dt: 20.05.2020, CPIO, POWERGRID, SR-I, Secunderabad was called and the grievance made in the Appeal was explained to him. He furnished that the RTI request was replied vide letter No. SRTS-I:RTI-120:3011:2020 Dt: 05.05.2020 within time.

CPIO further stated that the data pertaining to SR-1 has been submitted to Appellant vide above mentioned letter and informed that the data pertaining to NR-1 & CC is not available at our office.

**Decision:**

I have examined and sifted the documents connected in the matter and dispose of the Appeal as under:


- a) The Appellant had filed an Application dated 12.04.2020 seeking following information under the Right to Information Act, 2005:
  - 1) "Year wise data of Transfer applications received since 2015 from the employees having children with Disabilities, with details of date of initial request of the application, details of Transfer applications considered and concerned employee transferred to the place as requested in their application, details of transfer applications not considered and concerned employee not transferred as per their request (Reasons not required), details of Transfer applications pending and the reasons for pending, details of transfer applications under process. Information of SR-I, NR-I and CC may please be provided separately.
  - 2) No. of employees presently in executive cadre working at Regional Head Quarters of NR-I, Regional Head Quarters of SR-I and CC for more than 10 years as on 31.03.2020 (including all spells and areas (departments) of their postings). Information of SR-I, NR-I and CC may please be provided separately.
  - 3) No. of employees presently in executive cadre working at Regional Head Quarters as on 31.03.2020 (including all spells and areas (departments) of their postings) who were earlier transferred to other places and transferred back to Regional Head Quarters in period of less than 2 years. Information of SR-I, NR-I and CC may please be provided separately.
  - 4) Details of the Leased accommodation(s) sanctioned by POWERGRID for their employees at a place other their place of posting from 01.01.2012 to 31.03.2020. Information of SR-I, NR-I and CC may please be provided separately.
  - 5) As per norms, No. of employee postings sanctioned in executive cadre and no. of executive cadre employees posted, Details of vacancies and excess employees posted in the executive cadre in CC, regional headquarters of NR-I, regional headquarters SR-I, against the norms of POWERGRID. Information of SR-I, NR-I and CC may please be provided separately."

- b) The Reply provided to the Appellant vide letter Ref.No: SRTS-I:RTI-120:3011:2020 Dt: 05.05.2020 is found to be satisfactory. I sincerely convey our regret for the delay in disposing off the appeal due to pre occupation with official duties and due to Covid-19 restrictions.

Hence, the Appeal pertaining to SR-1, is disposed of accordingly.
