

Information related to para 2

It is informed that in terms of offer of appointment, executives may be posted anywhere in India as per the requirements of the organisation. Accordingly, on completion of training, executives are being posted based on suitability, performance, areas where they gained specific knowledge during training and as per the requirement in different establishment at the time of posting.

Further, RTI Act 2005 is means for citizens to secure access to information under the control of Public Authorities. Information is defined under Cl. 2 (f) of the said Act. The subject query asked does not fall under this purview.
