

- 2) Please provide me the procurement price of various rating 3 phase transformer.
 - a) Highest rate accepted from L1 or otherwise.
 - b) Lowest rate accepted from L1 or otherwise.
 - c) Transportation, loading and unloading expenses.
 - d) Price escalation if any.
 - e) Name of Substation and make of 3 phase transformer.

Reply: ICTs are normally procured as Supply cum Installation packages either as Transformer Packages or as part of Sub-station Packages. The details of Contracts awarded by Corporate Contract Services department of POWERGRID such as "Tender Description", "Name of L1 Bidder", "Contract Value", "Parties qualified in the subject tender", "Parties not qualified in the subject tender" is available on POWERGRID's website www.powergridindia.com under the head Tenders and then clicking on the tab Search Award of Contract (AoC)/ Amendments to AoC.

In this regard it may also be noted that the information in regard to details of any Contract pertains to Third Party which can be shared only after affirmation from Third Party.

Further, the information sought by the applicant is not available in the desired format. The information sought is voluminous in nature and gathering of the same would disproportionately divert resources of the Public Authority.
