

Query 1. Please provide the list of the 120 Substations under phase-I of the Project?

Query 2. Please provide the list of the 72 Substations under phase-II of the Project?

Reply 1&2. Information sought is of strategic importance under section 8(1) (a) of RTI Act, 2005. Hence, list cannot be provided.

Query 3. Please provide the dates when site fronts were handed over to GE/Alstom in each of 120 substations under phase-I of the Project?

Query 4. Please provide the dates when site fronts were handed over to GE/Alstom in each of 72 substations under phase-II of the Project?

Reply 3&4. Site fronts were available from date of award of LOA.

Query 5. Please provide the reasons why the contract between PGCIL and GE T&D India Ltd., was de-scoped from within the scope of GE T&D India Ltd., despite having such significant national importance.

Reply 5. The query does not qualify the definition of information under section 2(f) of RTI Act, 2005.

Query 6. Please provide the date on which full payment was done to GE T&D India Ltd., once the contract milestone was achieved?

Reply 6. Full payment not done.

Query 7. Whether PGCIL has ever liquidated damages on account of delay by GE T&D India Ltd.? If yes, please provide the amount recovered by PGCIL from GE T&D India Ltd., and on which date the said amount was recovered?

Reply 7. Liquidated damages will be settled while closing of this contract.

Query 8. Please provide if the Annual Maintenance contract for the maintenance of 120 substations of phase-I project has been awarded to any entity? If yes, please provide the name of entity and contract value and duration of the AMC contract, if any? Please also provide a copy of Annual Maintenance Contract for the maintenance of 120 substations?
