Information Sought (1) Copy of Communication in any form (letter, fax, email, DO letter, circular, whatsapp message, voice message, etc) from Ministry of Power or CEA requisitioning/ publishing such vacancies in CEA for PGCIL employees.

Reply: Requisite information falls under the definition of third party as per section 8(1) (J) of RTI act and requester has not mentioned about the link of the information with public interest. Hence, no documents can be provided.

Information Sought (2) Copy of documents including noting sheet, letters, etc containing the benefits envisaged to be accrued to PGCIL as a Corporation and its employee by such posting/ deputation/transfer to CEA.

Reply: Posting of POWERGRID executives is in lieu of CEA officers for field exposure and terms & conditions for the same is yet to be finalized.

Information Sought (3) copy of portion of service rules/ CDA rules of PGCIL executives mandating such requirement for its executives for posting in CEA, MoP or alike other organizations.

Reply: Such posting is done as per guidelines of Govt./administrative ministry from times to time.

Information Sought (4) copy of Communication in any form (letter, fax, email, DO letter, circular, whatsapp message, voice message, etc) from Department of public Enterprises for posting its employees (PSUs employees) in CEA, MoP or alike other organizations.
