
**OFFICE MEMORANDUM**

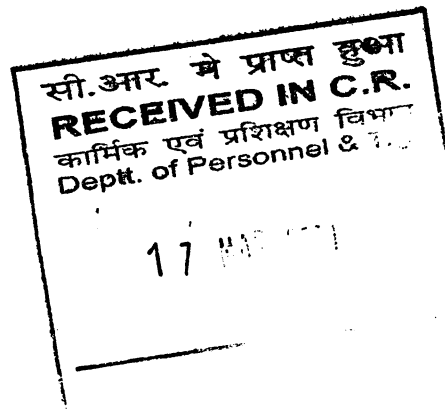
