ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal bearing number PGCIL/A/E/20/00031 dated 13th July, 2020 from Sh. Anurag Singhal. Earlier, the appellant herein had filed an application-bearing number PGCIL/R/E/20/00207 dated 04th June 2020, with the CPIO Corporate Centre, POWERGRID seeking certain information related to recruitment of ET-Finance. The instant appeal has been preferred by the appellant on the ground that the CPIO has not provided the information.

On receipt of the appeal, information provided by CPIO vide letter dated 13th July, 2020, and relevant papers were perused.

Decision:

I have perused the reply dated 02_{nd} July 2020 sent by the CPIO. I have also seen the RTI application dated 04_{th} June 2020, filed by the appellant wherein he had sought the information related to cut off marks in respect of written exam (CBT) as well as Group Discussion (GD) and interview for each category. Further, the appellant also sought information related to his marks in written exam, his response sheet along with correct answers considered for evaluation by POWERGRID and marks of selected candidates.

It seems that the appellant did not receive the requested information within the stipulated time hence, this appeal. It was informed by the CPIO that the requisite information has been provided to appellant vide email dated 2_{nd} July 2020, and the same has also been sent by post.

Be that as it may, CPIO is hereby directed to once again provide the information to the appellant through e mail as well as by post.

The appeal is accordingly disposed of.
