ORDER

Grounds of Appeal

The Appellate Authority has received an offline appeal bearing reference number FA/2020-21/373, dated 1st July, 2020 on 15th July 2020 from Mr. Sanjay Mishra vide Appeal. Earlier, the appellant herein had filed a RTI application on 04.06.2020 vide his letter dated 21.05.2020 with CPIO Corporate Centre, POWERGRID seeking certain information related to his representation dated 18.11.2018. The instant appeal has been preferred by the appellant on the ground that the CPIO has not provided the information within the stipulated time.

On receipt of the appeal, information provided by CPIO vide letter dated 23rd June, 2020, and relevant papers were perused.

Decision:

I have perused the reply dated 23rd June 2020 sent by the CPIO. I have also seen the RTI application dated 04th June 2020 filed by the appellant, wherein he had sought the information regarding against his representation dated 18.11.2018. It appears that the information sought by the appellant was not received by the appellant within the stipulated time. Hence he has preferred this appeal.

After perusal of the records, it is clear that the CPIO provided the requisite information to appellant vide letter dated 23rd June, 2020, which was sent through Post on 01/07/2020 (Consignment ID-EH668120904IN). The reply was sent within 30 days of receipt of the application. Be that as it may a copy of the reply dated 23rd June, 2020 is attached herewith for kind perusal of the appellant.

The appeal is accordingly disposed of.
