For query no 1, the pay scale of workmen category employees are not provided. For query no 4, the reply received is to refer para no 2 of DPE OM dtd 03.08.2017 and the same is quoting here. Revised Pay Scales: - The revised Pay scales for Board and below Board level executives would be as indicated in Annexure-I (Annexure-1 is E0 to E9 without any E2A and E7A and starred below E7 only in CPSEs of schedule A, B and C) There will be no change in the number and structure of pay scales and every executive has to be fitted into the corresponding new pay scale. In case of CPSEs which are yet to be categorized, the revised pay scales as applicable to the Schedule 'D' CPSEs would be applicable. The query is, As per the pay scales fixed by POWERGRID for Executive category employees WEF 01.01.2017, the above is not followed and requested for the copy of approval taken from the ministry of power/ Board of Directors or any other body for not to follow the para no 2 of DPE OM dtd 03.08.2017. Due to the above-mentioned issues in Sl no 1 &amp;2, I am not satisfied with the reply of the POWERGRID CPIO and it is requesting you to provide the full information</p> |  |                      |
