ORDER

Grounds of Appeal

The Appellate Authority has received an online appeal bearing number **PGCIL/A/E/20/00048** dated **06/10/2020** from Mr. Varghese Mathew, (appellant). Earlier, the appellant herein had filed an online RTI application bearing number **PGCIL/R/E/20/00290** dated **09/08/2020**, with the CPIO Corporate Centre, seeking information related to pay revision of POWERGRID employees. The instant appeal has been preferred on the ground that the CPIO has provided only partial information.

Order:

I have perused the reply dated 9th September 2020 sent by the CPIO and other relevant papers. I have also seen the RTI application dated 09th August 2020 filed by the appellant, wherein he had sought the information regarding pay revision of POWERGRID employees (Executives, Supervisor & workmen). As per the appellant, the annexure indicating the pay scales of workmen category employees

is missing. Further, the appellant has also sought information related to a query raised by him regarding noncompliance of DPE OM dated 03.08.17.

I have noticed that the reply which sent to the appellant does not have the annexure indicating the pay scales of workmen category employees. As far as query related to noncompliance of OM dated 03.08.17, is concerned, the same has already been replied to.

Be that as it may, the CPIO is directed to provide the information related to pay scales of workmen category employees within seven days from the date of this order.

The appeal is accordingly disposed of.
