ORDER

Grounds of Appeal

The Appellate Authority has received an online appeal bearing number **PGCIL/A/E/20/00047** dated **30/09/2020** from Mr. Anmol, (appellant). Earlier, the appellant herein had filed an online RTI application bearing number **PGCIL/R/E/20/00311** dated **24/08/2020**, with the CPIO Corporate Centre, seeking a copy of the letter dated 14.07.2020, sent by the Department of Telecommunications. The instant appeal has been preferred on the ground that the CPIO has not provided the information.


Order:

I have perused the reply dated 18th September 2020, sent by the CPIO and other relevant papers. I have also seen the RTI application dated 24th August 2020, filed by the appellant, wherein he had sought a copy of the letter dated 14.07.2020, sent by the Department of Telecommunications.

The same was denied by the CPIO citing section 8(1) (d). As per appellant the CPIO has failed to specify which third party would be harmed if the information is disclosed let alone any reason for the same.

In my considered opinion the letter in question was sent to POWERGRID hence, the information sought does not relate to any third party. Therefore, section 8 (1) (d) will not be attracted in this scenario. The CPIO is directed to provide the information within seven days from the date of this order.

The appeal is accordingly disposed of.
