
Please refer to your RTI applications dated 28.7.2020 registered in DoP&T vide the above reference number.

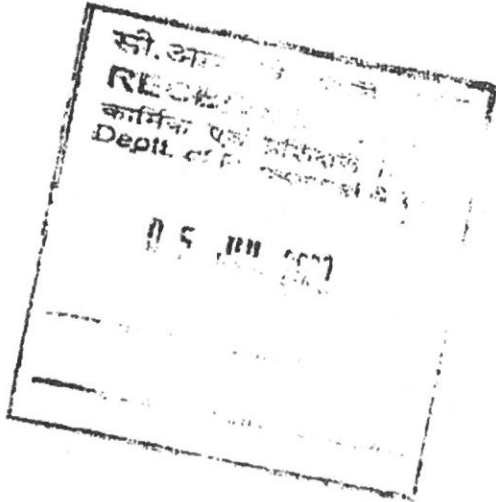

