

1	Types of leaves provided to the employees of Power Grid Corporation of India Limited?	POWERGRID employees are entitled to the following leaves, viz. Casual Leave, Special Casual Leave, Earned Leave, Half-Pay Leave, Commuted Leave, Extra-ordinary Leave, Maternity/Paternity Leave, Child Care Leave, Quarantine Leave, Terminal Leave, Compensatory Leave, Special Additional Leave, Special Disability Leave, Sabbatical Leave and Study Leave.
2	Whether there is any provision regarding special leave (SL) or special additional leave (SAL) or any other name as specified on account of working on Saturday?	<p>As per the RTI Act, 2005, "information" means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force". The information sought does not come under the aforementioned definition of information. Further, the public authority under the RTI Act is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions. Only such information can be had under the Act which already exists with the public authority.</p> <p>The above is a "query" and not "information" as per RTI Act. Accordingly, no document / information can be provided against the request.</p>
