Sub: not release any compensation amount to Smt.Ramakka and her children i.e., T.V.Murthy and others of Tharabanahalli Village, and to deposit the amount to court in F.D.P.No.5 / 2011 on the file of Hon'ble Additional Civil Judge, Devanahalli.,

Ref: Land bearing Sy.No.13/ P30 of Tharabanahalli Village, Jala Hobli, Bangalore North Taluk measuring 30 guntas of which is partly acquiring for extension of High Tension Lane

With reference to above subject I submit as follows:

I the undersigned is the elder son of Late Venkatappa born through Smt.Munivenkatamma of Tharabanahalli Village and he owns a property referred above and he died on 19.10.2009 leaving behind me.

I submit that during the life time of my father myself and my father entered in to a compromise decree in O.S.No.250 / 1999 dated 16.2.2000

on the file of the Civil Judge, Devanahalli. As per said decree I am entitle for 15 guntas out of 30 guntas of land in Sy.No.13 / P30. And I have filed F.D.P.5/2011 before the court to divide the property and to issue final decree. Said FDP proceedings is pending adjudication.

I further submit that, by suppressing all the facts narrated above the said Smt.Ramakka's children i.e., T.V.Murthy and others of Tharabanahalli Village have filed suit in O.S.No.94/ 2000 renumbered as O.S.No.141/2012 on the file of the Senior Civil Judge, Devanahalli and said case is also pending adjudication. Like wise said Ramakka also filed suit for maintenance against her children and me in O.S.No.85 / 2011 and I have appeared in both the case and contesting the same.

Such being the facts, now the said persons by suppressing all real facts they trying to mislead you to grab the compensation amount with my knowledge and information. I am herewith producing following documents in my favour for your kind reference.

Death Certificate of my father, Genealogical Tree, RTC, E.C , Mutation, Saguvalli Chit with sketch and plaint copy.

Hence I request your authority not to disburse the amount infavour of the said persons and further request you to deposit the compensation amount in FDP proceedings referred above.
