5	What procedures are followed during evaluation if the bid prices are higher than estimated prices for open tenders as well as risk purchase tenders?	
6	Does PGCIL apply the IEEMA pricing index formula to discover a fair bidding price against risk purchase tenders if the bid prices are disproportionately or inordinately higher than the original contract prices?
