Respected Sir,

Please refer my above mentioned RTI, wherein information was sought from the company regarding 8 points. I am in receipt of reply from the company for 8 points. I am disappointed with the reply received from the company. How a Company like Powergrid can reply like this. Reply itself suggest that the company is not willing to share the information with the public and is hiding not something but is trying to hide everything.

I have not been replied properly. It seems that the person replying was in some hurry and did not read my questionnaire/may be concerned person is having some ill motive. Otherwise there is no reason, why a PSU would not like to share the information with the public on whose money the infrastructure of the PSUs are built. Govt has brought RTI with a intention to bring transparency in the working of the PSU/Govt Dept. But it doesn't seem so with the reply received. Being a public servant, it is our responsibility to share information.

My pointwise submission is as under:

1)(a) It seems with the reply that a single GST Auditor has been appointed for the whole company. Single GST Auditor does all the reconciliation work for so many branches/units, which seems impossible/impracticable. Please confirm this.

I would request the concerned to get the information from that place and please put it here so that the same is available here.
- 5) Since reply to point no 4 has not been given properly, obviously this has not been replied too. Please give a proper reply.
- 6 & 7) Sabse faaltu Jawab. I am very specific in my question. Manner of appointing GST Auditor: LTE/Open Tender/One to one Negotiation/some other method which i am not aware of. You can yourself see the reply Respected Sir. I have asked for the Name of Authority like Name, his designation like CMD/CGM/GM/Director(Finance)/Head of Finance.
- 8)I would say once again the same thing that it is all public money which is being misused. It may so happen that this will save some public money. I am having information which indicates otherwise. Please give proper reply to my question.
