## **Grounds of Appeal**

The Appellate Authority has received an online appeal bearing number PGCIL/A/E/20/00069 on 29.12.2020 from Shri Virender Yadav. Earlier, the appellant herein had filed an online application bearing number PGCIL/R/E/20/00442, dated 24.10.2020, with the CPIO, Corporate Centre, seeking information related to status of payment against invoices submitted by him for supply of cleaning and hygiene goods to POWERGRID. The instant appeal has been preferred on the ground that the information provided by CPIO is misleading and incomplete.

## Order:

I have perused the reply dated 17.11.2020, given by the CPIO. Appellant in his RTI application dated 24.10.2020, had sought information related to status of payment against invoices submitted by him. In his application dated 24.10.2020 the appellant had also submitted the ledger details with invoice numbers from April 2014 onwards for reconciliation along with details of unpaid invoices. Further, the appellant had also sought the information related to time by which the pending bills would be paid.

CPIO vide his reply dated 17.11.2020, provided the detail of only one pending invoice of Rs 4928/- against appellant's claim of pending amount of Rs. 23771/-.

CPIO is directed to provide the details of all the unpaid bills submitted so far by the appellant along with information related to time by which the said bills would be paid, within fifteen days of this order.

The appeal is disposed of.
