**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online appeal bearing number **PGCIL/A/E/20/00055** dated **18.11.2020** from Shri Ramachandra (appellant). Earlier, the appellant herein had filed an online RTI application bearing number RTI/2020-21/19725 dated 23/10/2020, with the CPIO Corporate Centre, seeking a copy of all the documents pertaining to the complaint, which was closed on 27.12.2019. The instant appeal has been preferred on the ground that the CPIO has not provided the requisite information.

**Order:**

I have perused the reply dated 17<sup>th</sup> November 2020, sent by the CPIO. I have also seen the RTI application dated 23.10.2020, filed by the appellant, wherein the appellant had requested a copy of the documents pertaining to the complaint, which was closed on 27.12.2019. CPIO in his reply has categorically informed

that there are no additional documents available since the closed complaint, was not found worthy of investigation. The letter dated 07.10.2020 sent to the appellant by the vigilance department (letter enclosed by the appellant in his appeal), also reiterates the same thing that the complaint is closed as no vigilance angle was found in it.

In my considered opinion the information has already been provided to the appellant.

The appeal is accordingly disposed of.
