Reply: Vide aforesaid query, requester is requesting for information the disclosure of which has no relationship to any public activity or interest and would cause unwarranted invasion of the privacy of the individual under clause-8.1(j) of RTI act..

However for information of RTI applicant, it is to clarify that Sh Sukhwinder Singh, Emp No. 16892 was recruited against PWD vacancy of NR-II region in special recruitment drive for PWD conducted by NR-II. Since his posting was changed to NR-I because of change of Region jurisdiction, his request for change in posting to NR-II (i.e. region for which he was recruited) was considered and he was transferred to NR-II.
