Respected Sir/Madam,

**Sub:** Application seeking Information under Right to Information (RTI) Act, 2005.

It is requested to provide the following information under the RTI Act, 2005 for your company Power Grid Corporation of India Limited (PGCIL) and its subsidiary SPVs.

1. It is understood that a transmission licensee is bound to have insurance with respect to the transmission project executed by it, as per the terms of Transmission Service agreement (TSA), extract of which is as follows:

**9 INSURANCES**

**9.1 Insurance:**

*9.1.1 The TSP shall effect and maintain or cause to be effected and maintained during the Construction Period and the Operating Period, Insurances against such risks, with such deductibles and endorsements and co-beneficiary/insured, as may be necessary under*

- a. any of the Financing Agreements,*
- b. the Laws, and*
- c. in accordance with Prudent Utility Practices.*

*The Insurances shall be taken effective from a date prior to the date of the Financial Closure till the Expiry Date.*

**9.2 Evidence of Insurance cover:**

*9.2.1 The TSP shall furnish to the Lead Long Term Transmission Customer copies of certificates and policies of the Insurances as soon as they are effected and renewed by or on behalf of the TSP from time to time in terms of Article 9.1*

2. In regard to above-said, please provide information against Point number 3 to Point number 9 given below. This information should be provided separately for each of the following five (5) projects:
  - a. Transmission system associated with IPPs of Nagapattinam/ Cuddalore Area – Package A
  - b. Transmission system for Strengthening in Southern Region for import of Power from ER
  - c. Transmission system associated with LTA applications from Rajasthan SEZ Part-A
  - d. Transmission System Associated with Darlipalli TPS in Eastern Region
  - e. System Strengthening in Northern Region for Sasan and Mundra UMPP
3. Whether PGCIL/respective SPVs are complying with the project insurance requirements as mentioned in the respective TSA of the above-said five (5) projects.
4. Pls provide project-wise details whether such insurance has been done through 3<sup>rd</sup> party or through self-insurance. If through 3<sup>rd</sup> party, please provide name of 3<sup>rd</sup> party for each such insurance and corresponding name of project.
5. If any of the above-mentioned four projects has self-insurance, please provide details as to how self-insurance is provided/effected.
6. If it is done through self-insurance in case of above-mentioned RTM projects, whether each of such insurance has got approval from the board of directors of PGCIL? If yes, please provide copy of minutes of board meeting whereby such approval was obtained.

7. If it is done through self-insurance in case of above-mentioned TBCB projects, whether each of such insurance has got approval from the board of directors of such SPV(s)? If yes, please provide copy of minutes of board meeting whereby such approval was obtained.
8. Pls provide date of start of insurance and end date of insurance, separately for each of the above-mentioned five projects.
9. Further as per terms of TSA, PGCIL/SPVs are under obligation to inform Lead Long Term Transmission Customer (LLTTC) about the insurance. In this regard, kindly provide following:
  - a. Date when the LLTTC were last informed.
  - b. Provide copy of such communication sent to LLTTCs, complying to the TSA provisions.
