Following the instruction/order, the applicant removed/cut the trees which were standing on the way of transmission line of power. Kindly find enclosed red colored original slip issued by the officer of the corporation dated 15.10.2014 (1 page).	It is gathered that the said trees were not removed/ cut by the landowner after issuance of notice, inspite of repeated requests towards compensation. Incase landowner has removed trees, same may be intimated to concerned Kanpur TL office, so that joint verification may be carried out.
2.	Whether the applicant is entitled an appropriate compensation of trees which were removed/cut on the instruction/order of officer, as mentioned in the red slip as original annexed herewith?	Yes.
3.	Whether non-payment of compensation of damaged trees, despite repeated oral request for the same and passing long period of time is amount to dereliction of duties of a public servant?	
4.	Whether non action by the public servant on account of non-payment of compensation of damaged trees does not create suspicion that the payment of compensation for damaged trees was not made because illegal gratification was not paid?	views and thus, doesn't comes under the purview of RTI, Act 2005.
