## ORDER

#### **Grounds of Appeal:**

Being aggrieved by the information provided by the CPIO, POWERGRID, SR-I, Secunderabad, vide his letter No. SR-PSITSL-O-76I Dt: 03.12.2020 against the Request of the Appellant vide on-line application No. PGCIL/R/E/20/00465 Dt: 04.11.2020, the Appellant has filed this on the following grounds:-

The Appellant has stated that CPIO Office had not provided the requested information for the RTI Request Ref.No. PGCIL/R/E/20/00465 Dt: 04.11.2020.

On receipt of the Appeal PGCIL/R/E/20/00465 Dt: 04.11.2020, CPIO, POWERGRID, SR-I, Secunderabad was called and the grievance made in the Appeal was explained to him. He furnished that the RTI request was replied vide letter No. SR-PSITSL-O-76I Dt: 03.12.2020

CPIO further stated that he could not provide the requisite information as the details sought are of third party information and disclosure of such information as per Clause 8(1) (d) of the RTI Act, 2005 is exempted. Hence not provided.

# Appeal Reference No.PGCIL/R/E/20/00465 dated 04th November 2020

# Decision:

I have examined and sifted the documents connected in the matter and dispose of the Appeal as under:

- a) The Appellant had filed an Application dated 04.11.2020 seeking following information under the Right to Information Act, 2005:
  - "With respect to the high tension wiring project from Vemagiri to Chilakaluripeta 765 KV in 2018-19 year. Andhra Pradesh state, East Godavari District, please provide the following details:
  - 1) Rajanagaram Mandalam, kalavacherla Seetharampuram village these land survey numbers 117-1, 118-1, 147-1, 137-1A, 143-2, 134, 146-1, 143-1B, 119-1, 116, 138-1, 138-7, 135, 136, 139, 137-7 137-1121-1A1, 118 Land farmers names and were identified for how much compensation full details:
  - 2) In Rajanagaram Mandalam East Godavari district, A.P, State was there any crop damage. Farmers names and their land survey numbers, land tenants, survey numbers and tenant names and their compensation full details.
  - 3) Corridor land compensation statement of this transmission line local MRO giving copy was attached to this file."
- b) The details sought are of third party information and disclosure of such information as per Clause 8(1) (d) of the RTI Act, 2005 is exempted. Accordingly CPIO provided reply to the Appellant vide letter dated 03.12.2020.

Hence, the Appeal is disposed of accordingly.
