**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an appeal ref. **PGCIL/A/E/22/00030 dated 18/07/2022** from Sh. Satyajit Bardhan (appellant). Earlier, the appellant herein had filed an RTI application bearing reference number PGCIL/R/E/20/00483 dated 19/11/2020, which was returned to applicant 19/11/2020 stating that the information sought is not related to POWERGRID. The instant appeal has been preferred on the ground that the CPIO have not responded within the time limit.

**Order:**

I have seen the aforesaid RTI application wherein the applicant had requested to provide certain appointment letters in Assam Power Distribution Company Limited (APDCL). whereas in the instant appeal, the appellant has also sought additional information regarding certain appointment letters in Assam Power Generation Corporation Limited (APGCL).

It can be seen that the appellant was informed on 19/11/2020 (while returning the aforesaid RTI) that the information sought does not pertain to POWERGRID, however, he has preferred to file an appeal after lapse of almost two years. Be that as it may, ends of justice would be met if the appeal is sent to the appropriate authority.
