Respected Sir,

With reference to the above, kindly furnish me the following information (alongwith document/s) under the Right to Information Act, 2005 & the Rules thereunder at the earliest:

- (i) Kindly furnish me the bio-data of Shri Vijay Kumar, Ex-SSP, CBI (who was appointed as the Inquiring Authority vide Order No. CC: VIG/1690 dated 02.09.2019 to inquire into the Charges against Shri H.K. Phukan, Emp. No. 51252, as reflected in the Memorandum under Ref. No. CC/VIG/DP/2260 dated 16.06.2020 as issued by the CMD, POWER GRID & the Disciplinary Authority).
- (ii) Kindly state whether there has been any case(s) or incident (s) as regards aforesaid Shri Vijay Kumar, which is/are significant for him to be called as "honest public servant" touching the sphere of his honesty (positively or negatively), as per provision of Rule-25 (2) of the POWERGRID conduct, Discipline and Appeal Rules.
- (iii) Kindly state whether the aforesaid Shri Vijay Kumar is the lone "retired honest public servant" to enquire into as per provision of the aforesaid Rules-25 (2) of the POWERGRID CDA Rules, or there is a panel of "public servant or retired honest public servant" (s) for the same as per the said Rule-25(2).

If there exists a panel, then kindly furnish it to me with the no. of enquiries each of them have been entrusted with till date, with elaborate details of the aforementioned Shri Vijay Kumar's performances in his enquiries (whether respective charges have been established or not and whether concerned Disciplinary Authorities have accepted the inquiry

reports or not as well as post inquiry Court/Tribunal case/s and results thereof).

(iv) Kindly let me know elaborately whether the said Shri Vijay Kumar has been engaged to enquire into only by the Power Grid Corporation of India Limited, or any other Govt. agency or Department, etc. for that matter till date.

(v) Kindly furnish me the detail decision making process of deciding to appoint the said Shri Vijay Kumar as the Inquiring Authority in case of the aforementioned Shri H.K. Phukan.

(vi) Kindly furnish me the bio-data of Shri Arun Gogoi, who was appointed as the Presenting Officer in the aforesaid inquiry as regards Shri H. K. Phukan and the details of cases he has appeared as a Presenting Officer till date and outcomes thereof (including results of post inquiry Court/Tribunal case(s), if there is/are any).

2. Kindly furnish me a copy of the POWERGRID CDA Rules (Revised), with details of the Revision/amendment date(s), etc. as well as effective date(s), etc. thereof.
3. Kindly furnish me the entire documents/Enclosures of the Inquiry Report dated 28.02.2020 as prepared and authored by the aforementioned Shri Vijay Kumar as regards Shri H.K. Phukan, Emp. No.- 51252 (with reference to the Memorandum under Ref. No. CC/VIG/DP/2260 dated 16.06.2020 as issued by the CMD, POWERGRID & Disciplinary Authority), particularly as indicated in 5 nos. of "Encls" at the last portion of page no.- 19 of the said Inquiry Report dated 28.02.2020.
