

Sub: - Construction of 400 kV D/c Pavagada - Devanahalli Transmission line – Resolution of dispute of BEML Layout in Bagalur Village – Deposit of compensation – Reg.

At the outset, we thank your good offices for the support being received for execution our transmission line works and We are in receipt of compensation order vide referred above in respect of various villages falling our Transmission line which was passing through kuduregere, Gadenahalli, Navaratna Agrahara, Tharabanahalli, Meenukunte, Doddajala Amanikere, Doddajala, Huttanahalli & Kudugere villages falling under Jala hobli of Yelahanka Taluk and the construction works are under progress.

During the execution of our Transmission line, our transmission line is passing thorough the layout of BEML under the survey numbers of 427, 176, 438 etc of Bagalur village. It is observed the subject lands are under the various court cases, litigations etc and it is also understood that these land owners are under illegal occupation of the Government lands. The land owners are not allowing us to take up the foundation works. The tentative extent of the lands falling under this layout and the tentative compensation amount to be paid is enclosed at Annexure-1.

In view of the above, we request your kind self to issue suitable order for deposit of compensation with the District Administration so that the compensation may be released to the land owners after resolution of disputes & confirmation of the ownership. We also request your kind self to provide necessary protection/ support to take up construction activities at this layout.
