

Query 1:

Public Procurement (Preference to Make in India) (PPP-MII), Order 2017 including revision thereof, specify the definitions of terms 'Nodal Ministry' and 'Procuring entity' and not the term 'Nodal Officer'.

It may however, be mentioned that POWERGRID has already implemented the PPP-MII Order in its procurement and bidding documents.

Query 2 :

Please provide me about the amount of imports undertaken by various Departments and CPSE's under your Ministry between 15.06.2017 to 31.03.2020 and also the amount of Proprietary purchase made by you during the same period.

Reply:

/proprietary basis, including brief description of item, value of order, order number and date.
