**ORDER**

**Grounds of Appeal**

The Appellate Authority has received online appeals bearing reference number PGCIL/A/E/21/00009 on 24.02.2021 from Shri Sallarapu Harsha Vardhan Reddy. Earlier, the appellant herein had filed online RTI application bearing reference number PGCIL/R/E/21/00034 dated 17.01.2021, with the CPIO Corporate Centre, seeking information related to implementation of revised list of posts for Persons with disability (PwD) for recruitment of executive / management trainee.

**Order:**

I have seen the RTI application filed by the applicant and the reply dated 11.02.2021 given by the CPIO, wherein link has been provided to access the requested information. Further, it was also stated that list of posts reserved for PwD has been revised as per the Act, and the same are available in the referred website link.

Appellant has contended that the Department of Disabilities had recently released new list and requested for status of implementation of the same. He had also enclosed the extract of notification of Department of Empowerment of Persons with Disabilities (Divyangjan) dated 04<sup>th</sup> January 2021.

In view of recent notification revising the list of post for PwD by Department of Empowerment of Persons with Disabilities (Divyangjan), CPIO is directed to

provide the status of implementation of revised notification dated 04.01.2021, within seven days from the date of this order.

The appeal is accordingly disposed of.
