ORDER

Grounds of Appeal

The Appellate Authority has received online appeal bearing reference number PGCIL/A/E/21/00013 on 19.03.2021 from Shri Nikhil Nagar. Earlier, the appellant herein had filed online RTI application bearing reference number PGCIL/R/E/21/00042 dated 22.01.2021 with the CPIO Corporate Centre, seeking information related to Power Grid Executive (Finance) CBT exam dated 31.10.2020. The instant appeal has been preferred on the ground that the CPIO has not provided the requisite information

Order:

I have seen the RTI application and the reply dated 19.02.2021 given by the CPIO. CPIO vide its reply had provided the master answer key, answer sheet of the appellant. Further, the appellant was also informed that though there is no method for re-checking, however a candidate may submit his grievance(s) through official recruitment email/RTI/Public Grievance portal.

Appellant has contended that he was denied the information pertaining to shortlisted candidates considering the joining of candidates was not completed. In my considered opinion the names/roll numbers of selected candidates and cut-off marks under each category could have been provided by the CPIO.

Appellant has also contended that he had asked for list of questions along with answers key for verification, but the same was not provided by CPIO. CPIO has submitted that questions are acquired by POWERGRID after payment of due fees to a third party and may be used for recruitment in future as well.

Ends of justice would be met if the appellant may be allowed to access the information through inspection.

CPIO is directed to provide access (in person) to appellant for seeing the question paper of the examination for which he appeared for. CPIO may inform the preferable/convenient dates on which the appellant may come for inspection and share the category wise cut-off marks considered for shortlisting and provide list of names/roll numbers of selected candidates, within seven days from the date of this order.

The appeal is disposed of.
