## RTI

- . Particulars of information required :
- 1. Detailed procedure of applying for re-checking.
- 2. List of questions attempted by me (Roll No. 07103076) along with the answers selected by me and the correct answers. If it is not possible then provide me the alternative grievance procedure to verify my answers whether they are correct or not.
- 3. Provide me the name of students or roll numbers shortlisted for interview with their marks obtained in PKT and EAT separately for each category.
- 4. Why do you not provide any grievance procedure to students who are not satisfied with their marks? If it exists then why do you not inform to the students about it by email or through public notice?

## **Appeal**

In respect of information sought in serial no. 2, they just have provided an answer key which only contains question no. and their correct option like A, B, C... etc. But I have also asked for list of questions attempted by me to recheck my answers. So, you are requested to kindly provide the same if it is not possible than please provide me alternative grievance procedure to verify my answers. In respect of information sought in serial no. 3, I asked for list of candidates called for interview on the basis of marks in the online test along with their score in PAT & EAT separately for each category. But they might be confused it with final selection of candidate and said joining of candidates is still in progress so we cannot provide the information. So, you are requested to kindly provide me the requisite information. In respect of the information sought in serial no. 1 and 4, by just simply saying we don't have it or not commenting on their failure is itself not satisfactory and I am not satisfied with their reply and for which I will file a petition in High court for depriving the right of student to verify their own answer sheet and will also demand stay on selection procedure until they provide option for recheck & grievance to all the students.

- ii. The name of students or roll numbers short listed for interview with their marks obtained in PKT and EAT separately for each category are enclosed at Annexure If
