

Please refer to the above mail. Sri.Johnson S/o Sebastian Kambuzha has been paid an amount of 16487/-towards compensation for an extent of 2.75 Ares of land involved in Tower standing area as per file no.LV103/12/KT of this office.

It is seen that an extent of 3.63 Ares of land comprised in Survey No.752 in Amballoor Village, Mukundapuram Taluk falls within the corridor area between the Towers 175 and 176. The ownership of this piece of land could not be ascertained since nobody produced the documents to prove the title.Hence DVS of this piece of land has not been approved so far.If the land comprised in Survey No.752 which falls within the corridor area is under the possession of Sri.Johnson,he can claim the compensation on production of documents.
