Respected sir,

Namaste.

I applied and requested before u on 13/1/2021 by way of off line application under R.T.I Act with regard to the information of S.NO.143/p, wherein towers installed by you in the surroundings of Srikakulam District, Kasibugga office, Palasa, Gurudasapuram, Ramakrishnapuram village, Patta No.26 and the details of plot owner and agreement in between you and the owner and its complete details.

But you have not furnished any information under R.T.I Act and simply you stating that the above information is exempted from under clause 8(1)(d) of the R.T.I Act.

As per R.T.I Act 8(1)(d) specifically dealt that "**information including commercial confidence, trade secrets or intelliectuai property, the disciosure of which would harm the competitive position of a third party, unless the competent authority is satisfied that longer public interest warrants the discloser of such information.**

In the present matter I entered into an agreement for sale with one Jogi Mohana rao who was already entered an agreement with you in respect of the same land in s.no.143/p and he suppressing the agreement with you before me at the time of our sale agreement to an extent of total Ac.4.00 and received the advance also from me. But actually Ac.2.60 cents land only he has got on that s,no, after agreement with you. You installed towers in Ac.1.60 cents out of Ac.4.00.

Some of the public also entered an agreement with me for purchasing for the plots from me. Now the said Jogi Mohana rao raised dispute and demanding me to be paid sale consideration in respect of the total extent Ac.4.00. and also he has not turned to registration also and trying to prepare some fraudulent documents in the name of third parties.

I intend to proceed against him through a competent court of law. To prove my contentions before the Hon'ble court it is very essential for the information which I represented before you under R.T.I Act.

Unless the entire information in between jogi mohan rao and your corporation in respect of the property covered under 143/p of Ramakrishnapuram, Palasa, srikakulam distric has not been furnished under R.T.I act to me, I shall sustain irreparable loss and injury.

I herewith undertake that I never misuse the information at any point of time except to prove my contention before the Hon'ble Court.

I therefore request the competent authority may be pleased furnish the information what I required under R.T.I Act in the interest of justice.
