This has reference to Your RTI application dated 17.03.2021 which has been received at this office on 18.03.2021. The information required by you under RTI Act 2005 is as under:

The applicant is skilled worker at your office and he served duty including overtime and holidays work from 01/03/2016 to 31/08/2019 but he could not get his remuneration. Kindly provide the information as to why he could not get the same and upto what extent his remuneration is out standby.	We would like to state that your goodself has neither been deployed by POWERGRID nor there exist any relationship between you and POWERGRID, therefore any grievance with regard to your employment is required to be raised at your employer i.e. M/s RL Padmawar. It is also submitted that M/s RL Padmawar is neither a subsidiary nor an agent of POWERGRID. M/s RL Padmawar is an independent contractor. The relationship between M/s RL Padmawar and POWERGRID is only of contractual nature and which does not confer any liability on us with respect to payment to yourself. It is submitted that the difference and dispute between yourself and M/s RL Padmawar is moderated by the agreed terms as to which POWERGRID is neither party nor consented to it. Therefore the information regarding remuneration arising from overtime and holiday work from 01/03/2016 to 31/08/2019 cannot be attributed to POWERGRID and may be resolved directly with M/s RL Padmawar.

The first appeal, if any, against the reply of PIO may be made to the first appellate authority within 30 days of receipt of reply of PIO.
