Query 1.	What is the transfer policy for disabled employees/ care taker of disabled dependent in your organization?
Reply 1.	Please refer to clause 5.6.1 of POWERGRID's Transfer Policy for Executives reproduced below: <i>"Preference shall be given for request transfer to otherwise abled/differently-abled executives. Preference for request transfer shall also be given to executives having abled/diferently-abled children."</i>
Query 2.	Do in your organization have circulars of DoPT applied?
Reply 2.	POWERGRID takes cognizance of DoPT circulars issued on different matters. However, applicability of any particular DoPT circular is dependent on relevant instructions from DPE as well as the Ministry of Power.
Query 3.	Is DoPT Circular F.No. 42011/3/2014-Estt.(Res) dated the 08 th October, 2018 regarding the relaxation in transfer of employee or care taker of disabled dependent applicable in your organization or not?
Reply 3.	POWERGRID has taken cognizance of the said DoPT circular.
Query 4.	Please provide me details how many disable employees/ disable dependent in your organization?
Reply 4.	Disabled employees on regular rolls of the Corporation as per available data : 209 (Two Hundred Nine). Disabled dependents as per available data : 20 (Twenty).
Query 5.	If you have any circular regarding different kind of benefit/ facilities for disabled employees/ care taker of disabled dependent in your organization?
Reply 5.	POWERGRID provides reservation in appointment as well as relaxation in selection process for candidates belonging to PWD category as per DoPT guidelines and the applicable Act. In addition, employees belonging to PwD category are provided different benefits/ facilities such as accessibility assistance, relaxation in TA Rules, additional Special Casual leave as per POWERGRID Leave Rules and preference while exercising choice of posting as per Transfer Policy for Executives.

	However, there is no single circular enumerating all such benefits.
