**ORDER**

**Subject: RTI Appeal of Shri Quyadat Ali, Appeal Registration No. DPENT/A/E/21/00014 dated 25.03.2021- regarding.**


Shri Quyadat Ali vide his online RTI Application (registration No. DPENT/R/E/21/00114, dated 08.03.2021) had sought information regarding, *“the 3 (three) certified copies of the following data(s)/ records/ documents for the last 20 years as per the section 2(i) and under section 6(3) of the RTI Act, 2005 in all the CPSEs. 1. All the approval (including notes, office order, memos) of the funds used/utilized and sanctioned for the women’s day. 2. All the names of the chairperson in the women’s day celebration (year-wise). 3. Total amount/funds (Rs) spend in the women’s day celebration (year-wise) 4. Total funds (Rs.) allocated to the celebration of women’s day (year-wise). 5. Names and addresses of the venue, where the women’s day celebration took place (year-wise). 6. Total numbers of invitees and participate in the women’s day celebration (year-wise). 7. All the receipts of the payment (bills, cash memos) made to the parties involved in women’s day celebration (year-wise). 8. Details of the gifts presented to the chairperson and other members in the women’s day celebration.”*

In this connection, the following has been observed:

- (i) CPIO vide online registration no. DPENT/R/E/21/00114 has informed the applicant that the desired information is not compiled by DPE.
- (ii) Shri Quyadat Ali vide his RTI appeal (registration No. DPENT/A/E/21/00014 dated 25.03.2021) has filed a first appeal against the CPIO on the grounds to transfer the RTI to concerned public authority.

I have carefully gone through the records and state that the CPIO has correctly informed that no such information is compiled in DPE. CPSEs are board-driven independent commercial corporate entities. No CPSE functions under the administrative control of DPE. Therefore, this appeal along with RTI application is being transferred herewith to the CMDs of all the CPSEs with a request to furnish the desired information to you directly.

The appeal is disposed of accordingly.
