Sub.: Reply to RTI Query by Shri Uppuluri Krishna Murty, Andhra Pradesh.

Information Sought:

Query 1: Were the CVOs who joined the Power Grid Corporation of India Limited (PGCIL) during the year 2016 given the option for IDA Pay Scales of a Director Level post at PGCIL?

Reply 1: Yes. Shri V.K. Saxena joined POWERGRID on 25.07.2016 as CVO on deputation basis and opted to draw pay of the post of POWERGRID.

Query 2: At the time of joining PGCIL as CVOs during the year 2016, have they joined after availing the 7th Central Pay Commission (CPC) Pay Scales under the CDA Pay Scales Pattern which were implemented with effect from 01.01.2016?

Reply 2: No. 7th Central Pay Commission Pay Scales under CDA Pay Scales pattern was not revised at the time of joining POWERGRID on deputation.

Query 3: Were they fitted in to the IDA Pay Scales as prevailing in 2016 (II Pay Revision Committee Pay Scales effective before 31.12.2016) up on their joining the PGCIL?

Reply 3: Yes. As per DOPT OM DT. 12.07.2012, the post of CVOs in all CPSEs irrespective of the level/status/schedule of such CPSE shall be in the scale of pay equivalent to the level of functional Director in that CPSE. Accordingly, his basic pay was fixed provisionally at Rs.85240 in the pay scale of functional director (Rs.75000-100000). After revision of pay scale in Central Government w.e.f. 01.01.2016, his basic pay was fixed at Rs.2,11,300. w.e.f. 01.07.2016. Accordingly, his basic pay in POWERGRID was fixed at Rs.100,000/- and Rs.3300 as Personal Pay provisionally and informed to MOP. Vide letter dt. 01.03.2017, MOP again issued terms & condition of appointment and fixed his basic pay as 100,000 and Rs.340 as personal pay.

Query 4: Were the CVOs who had been fitted in IDA Pay Scales given the fitment benefit of 15% on Basic Pay and DA while implementing the revised IDA Pay Scales for the CVOs along with the other Board Level and Below Board Level Executives of PGCIL as per the III Pay Revision Committee (PRC) Recommendations implemented with effect from 01.01.2017 at PGCIL?

Reply 4: Yes. After pay revision, pay scale of functional Director in POWERGRID was revised to Rs.1,80,000 – 3,40,000 w.e.f. 01.01.2017. On approval, basic pay of Shri Saxena was provisionally fixed at Rs.2,20,000 as on 01.01.2017 and after giving 15% fitment benefit as per pay revision in POWERGRID w.e.f. 01.01.2017, basic pay of Shri Saxena was fixed at Rs.2,52,430 and the same was communicated to Ministry of Power.
