Power Grid Corporation of India Limited (A Government of India Enterprise) have been entrusted (by Government of India) with the establishment of \pm 800KV HVDC Raigarh (Chattisgarh) – Pugalur (Tamilnadu) Transmission System to evacuate 6000 MW power from Chattisgarh to the power deficit states of Southern Region. As part of the above scheme, \pm 800KV HVDC Transmission Line (about 1850 KM) with 6000MW capacity shall be constructed from Raigarh (Chattisgarh) to Pugalur (Tamilnadu). The said line shall pass through the States of Chattisgarh, Maharashtra, Telangana, Andhra Pradesh and Tamilnadu.

As this is a prestigious project entrusted to POWERGRID by Govt. of India on request from the Govt. of Andhra Pradesh, the said Transmission Line is planned to be completed by December'2018. The works for the project are under progress. In Chittoor District, the line passes through Kalakada, Kalikiri, Pileru, Sodam, Somala, Irala, Thavanampalle, Bangarupalyam, Yadamari mandals.

During the construction works like foundation, erection, stringing works of the above said transmission line; vegetable crops in the construction area of the land could be damaged. As per the guidelines provided by Government of India, compensation has to be paid to the land owners/farmers for the damaged vegetable crops in their land. As said above for the payment of compensation to the damaged vegetable crops to the land owners/farmers, the assessment rate is required from your kind office for the following vegetable crops for payments throughout the Chittoor district.

In this regards, kindly we request to issue the vegetable crops market rate in acre for <u>Tomato</u>, <u>Chillies</u>, <u>Papaya</u>, <u>Mango</u>, <u>Watermelon</u>, <u>Coconut</u> for payment of compensation to the landowners/farmers for the vegetable crops damaged during the construction activities.
