Information Sought:

Query 1: A list of all government employees of your Ministry who succumbed to COVID-19 since April 1, 2020. I need this information as per Name/ Designation/ Service/ Date of demise.

Reply 1: Medical information of employees is personal information. Thus as per Sec 8(1)(j) of RTI Act 2005, personal information the disclosure of which has no relationship with any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual is exempted from disclosure.

Query 2: Kindly provide a total designation wise number of employees of your Ministry who have got vaccinated with one dose of Covid-19 vaccine.

Reply 2: In POWERGRID, 6077 employees have been inoculated with 1st dose of vaccine. We do not maintain designation wise data.

Query 3: Kindly provide a total designation wise number of employees of your Ministry who have got vaccinated with both doses of Covid-19 vaccine.

Reply 3: In POWERGRID, 866 employees have been inoculated with 2nd dose of vaccine. We do not maintain designation wise data.

Query 4: If your Ministry have prepared any report/ analysis of the infection/deaths of employees of your department due to Covid-19, Kindly provide a copy of that.

Reply 4: Medical information of employees is personal information. Thus as per Sec 8(1)(j) of RTI Act 2005, personal information the disclosure of which has no relationship with any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual is exempted from disclosure.

Query 5: Any other information related to efforts to protect your employees from infection of Covid-19.

Reply 5: No specific information has been sought by the applicant. Further "Any other information" does not fall under definition of "Information" under Sec 2(f) of RTI Act 2005.
