With respect to your above referred request (**PGCIL/R/E/21/00215**) under Right to Information Act, 2005, please find information as under-

1. POWERGRID Mithilanchal Transmission Limited, (in Short "PMTL") is a 100% wholly owned subsidiary of Power Grid Corporation of India Limited, which is a "Maharatna" Public Sector Under Taking, Under Ministry of Power, Government of India, having its registered office at B9, Qutub institutional area, KatariaSarai, New Delhi 110016 and one of its office at Board Colony, Shashtri Nagar, Patna-23.
2. Prior approval under section 68 of Electricity Act, 2003 for the construction of 400 KV D/C Darbhanga to Sitamarhi transmission line has been sanctioned by government of India. Thereafter in exercise of the powers conferred under section 164 of the Electricity Act of 2003, the Central Government being the 'Appropriate Government' has conferred the power of Telegraph Authority upon PMTL vide Gazette dated 14.05.2019, hence PMTL as a transmission licensee is conferred with power of telegraph authority under part III of the Indian Telegraph Act 1885 and thus authorised to lay the poles wires post etc. upon across along over or under any immovable property as per the section 10 of the Indian Telegraph Act.
3. The said provisions conferred the power and authority upon the PMTL to erect transmission towers and string the lines. Further, Hon'ble Patna High Court in its various Judgments and Hon'ble Supreme Court of India in the



case between Power Grid Corporation of india Limited and Century Textiles, (2017)5SCC143 have upheld the above right and legal position of Telegraph Authority for the construction of transmission lines. Hon'ble Supreme court has also held that prior consent of land owners are not required for construction of transmission line by Telegraph Authority. Hon'ble Supreme court has also observed that, "As per the provisions of the Telegraph Act, 1885, unobstructed access to lay down telegraph and/or electricity transmission lines is an imperative in the larger public interest. Electrification of villages all over the country and availability of telegraph lines are the most essential requirements for growth and development of any country, economy and the well-being/progress of the citizens. **The legislature has not permitted any kind of impediment/obstruction in achieving this objective and through the scheme of the Telegraph Act, 1885 empowering the licensee to lay telegraph lines, applied the same, as it is, for laying down the electricity transmission lines.** Power Grid acquires all such powers which are vested in a telegraph authority including **power to eliminate any obstruction** in laying down of power transmission lines".
