Under the provisions of the RTI Act, kindly furnish the following in relation to the 20 Lakh Crore Stimulus Package introduced by the FM in 2020 to tackle pandemic related issues-

Fourth and Fifth Tranche

1. The Package also contemplated easing utilization of the Indian air space to reduce air travel cost. Kindly furnish what **steps** were taken till date towards this, and the amount **allocated** and **used** till date, including the **balance** remaining. Whether a tentative date has been set for bringing in a final policy and if so, when?
2. The Package also contemplated private participation in the space sector along with coming up with a policy for private players. Kindly furnish what steps were taken till date towards this and the amount **allocated for this Policy** and amount **used** till date, including the **balance** remaining. Whether the policy has been formulated and the current status of such a policy. Whether a tentative date has been set for bringing in a final policy and if so, when?
3. The Package also contemplated announced the commercial mining in the coal sector and privatizing discoms in metros. Kindly furnish what steps were taken till date towards this and the amount **allocated** and **used** till date, including the **balance** remaining. Whether the policy has been formulated for each of them and the current status of such a policy. Whether a tentative date has been set for bringing in a final policy and if so, when?
4. Out of the additional 40,000 crore allocation to MGNREGA, how much was **allocated**, was **sanctioned**, and **disbursed** on which **date**. State-wise and sector-wise data be provided, INCLUDING the **dates when each disbursement** to each state was made.
5. The Package also contemplated the formulation of a new Public Sector Enterprises Policy that would allow for consolidation of the PSU firms in strategic sectors. Kindly furnish what steps were taken till date towards this and the amount **allocated** and

used till date, including the balance remaining towards this Policy. Whether the policy has been formulated and the current status of such a policy. Whether a tentative date has been set for bringing in a final policy and if so, when?

Please Note: Most questions seek pointed data, like allocated amount, disbursed amount, spent amount, and remaining balance amount. This Applicant has **boldened** and **underlined** the important data categories that are required. Kindly keep them in mind and **kindly very carefully ensure that the data is provided for each such category.**

The Ld. CPIO is requested to transfer the RTI, **if required**, to other CPIOs **WITHIN** 5 days from receipt of this RTI u/s 6(3) of the RTI Act. The Ld. CPIO is requested not to violate this provision by transferring the RTI after 30 days or while sending a reply. The same should be done **WITHIN** 5 days from receipt.

Not doing so, even when required, will be an illegal act deliberately committed by the Ld. CPIO.
