6. Under the supervision of which department or respective officers, did the auction take place Name, date, address, mobile number, people who purchased the respective government vehicle under the auction, and mode of payment either through cash or bank transactions. These details are in need to be submitted.

The above requested details must be responding with necessary all documents or proof for evidence with authorized signature.

I humbly request you to provide me with the answers to the above questions in a timely manner, with appropriate documents under RTI Act-2005.
