ORDER

Grounds of Appeal

The Appellate Authority has received an appeal **dated 10/08/2021** from Mr. Rajesh Kumar, (appellant). Earlier, the appellant herein had filed an RTI application dated **28/07/2021**, with the CPIO Corporate Centre, seeking certified copies of complete Annual Appraisal Report for the calendar year 2017,2018,2019 & 2020 and details thereof. The instant appeal has been preferred on the ground that the CPIO has provided incomplete information.

Order:

I have seen the RTI application dated 28th July '21, filed by the appellant, wherein he had sought the certified copies of complete Annual Appraisal Report for the calendar year 2017,2018,2019 & 2020 and details thereof. I have also perused the reply dated 28th July'21 sent by the CPIO and other relevant documents. It can be seen that vide its reply the CPIO had communicated that as per established procedure of disclosure of Appraisal Rating, there is no provision for furnishing detailed Annual Appraisal Reports. The CPIO has furnished final rating of said four years.

The Applicant has however, requested copies of complete Annual Appraisal Report in the original application. The Applicant has also requested this in the Appeal dated 10th August 2021.

The CPIO is hereby directed to provide the information to the appellant within fourteen days of this order.

The appeal is accordingly disposed of.
