ORDER

The Appellant **Shri Om Prakash S/o Shri Khem Ram, VPO Ratta Kalan, Tehsil Ateli Mandi, District Mahendergarh(Haryana)-123021** vide RTI Application Dt.18.06.2021 has requested for furnishing certain information under the Provisions of Right to Information Act, 2005. Vide Letter No.PKTSL/RTI/21/242 Dt.05.07.2021, CPIO POWERGRID Khetri Transmission System Limited (PKTSL) had furnished information under the provisions of RTI Act, 2005.

Now, first RTI Appeal Dt.16.07.2021 along with Postal Order No. 53F 376962 and letter dt.16.07.2021 along with Postal Order No. 53F 376963 u/s 19(1) of the RTI Act, 2005 has been filed/sent by **Shri Om Prakash** in the office of undersigned. In his appeal, appellant has mentioned the information received by him from CPIO, PKSTL has not been sought by him. In his appeal he has sought information against Point No.1&2.

In other letter dt.16.07.2021 received in the office of undersigned along with Postal Order No.53F 376963 he has sought additional information which was not sought by him in his RTI application Dt.18.06.2021. Now, the appellant Shri Om Prakash has also sent First Reminder Dt.16.08.2021 (received on 19.08.2021) vide in he has mentioned that the reply of appeals Dt.16.07.2021 has not been received so far.

Ongoing through the contents of RTI Application Dt.18.06.2021 and immediately on receipt of appeals Dt.16.07.2021, CPIO, PKSTL was directed to provide information desired by the Appellant as per the provisions of RTI Act. Now, on the directions issued by the undersigned on receipt of First Reminder Dt.16.08.2021, CPIO, PKTSL has informed that vide Letters No.PKTSL/RTI/21 Dt.11.08.2021 reply/information desired by Shri Om Prakash has already been provided.

Now from the above, it is emerged that the information desired by the appellant has already been provided by CPIO PKTSL vide his letters No.PKTSL/RTI/21 Dt.11.08.2021 (copy enclosed). Hence Appeal Dt.16.07.2021 are disposed-off.
