FACTS

The CPIO vide letter dated 01.02.2019 gave point-wise reply to the Appellant. Dissatisfied with the reply received from the PIO, the Appellant filed a First Appeal. The FAA vide order dated 01.04.2019, upheld the reply of the CPIO. Thereafter, the Appellant filed a Second Appeal before the Commission with a request to provide information.

HEARING:

Facts emerging during the hearing:

The following were present:

Appellant: Mr. Anoop K M present through AC,

Respondent: Mr. V. Rajesh Sr. GM present through AC.

In order to ensure social distancing and prevent the spread of the pandemic, COVID-19, the hearing of the matter was scheduled through audio conference after giving prior notice to both the parties.

The Appellant reiterated the contents of the RTI applications and stated that he had sought information regarding copy of his transfer note sheets etc, which was not causing any unwarranted invasion of privacy of any other individual and the same cannot be denied to him under the section 8(1) (j) under the RTI Act, 2005. The Appellant further stated that the reply received from the Respondent was not correct as per the provisions of the RTI Act, 2005. The Appellant requested the Commission to direct the public authority to furnish correct information to him. When queried the Respondent submitted that due to lockdown situation they had received the file today morning only.

DECISION:

Keeping in view the facts of the case and the submissions made by both the parties, the Commission observes that proper reply has not been furnished by the Respondent. Therefore, the Commission directs the Respondent to furnish correct and an updated and revised reply to the Appellant as sought in the RTI application in accordance with the spirit of transparency and accountability as enshrined in the RTI Act, 2005, within a period of 30 days from the date of receipt of this order under the intimation to the Commission.

The Appeal stands disposed accordingly.
