

Sub.: Reply to RTI Query by Shri Sumit Karmakar, West Bengal.

Information Sought:

- You are requested to kindly furnish the Eligibility Criteria for vendor enlistment for reinforcement steel (TMT Bar)?
- You are requested to please provide the vendor enlistment procedure for reinforcement steel (TMT Bar)?

Point wise reply is given below:

1. For POWERGRID Projects, any TMT manufacturer who meets the following criteria is considered for approval after assessment:
 - i) Statutory requirements like valid Factory License/Registration, BIS 1786, Consent to Operate from State Pollution Control Board.
 - ii) General Aspects like proper organization structure, adequate experienced and qualified manpower, storage and handling facility etc.
 - iii) Credentials of past supply.
 - iv) Sufficient Product manufacturing facilities including inspection of raw material, finish material, in-process inspection etc.
 - v) Testing and measurement facilities with calibration from accredited labs.
 - vi) Quality Assurance Plan for raw material inspection, in-process monitoring, finish product testing etc.
 - vii) Traceability of finish product to heat number of Billet Cast.
 - viii) Environmental, safety and social aspects.
 - ix) Energy conservation and efficiency.
 - x) Any other parameter required for smooth functioning of plant which may affect the production or quality of product.
- 1.2 During assessment of the TMT manufacturer works by POWERGRID, above issues are assessed and/or verified. Based on assessment, TMT manufacturer is approved or rejected or shortcomings are conveyed for compliance. If the shortcomings are complied with, within given time frame, TMT manufacturer is approved, initially for one year, and thereafter renewal is accorded based on supply performance.
2. In POWERGRID, following is the process of approval for TMT manufacturer (vendor):

- a) Any vendor may request POWERGRID for its approval by writing to POWERGRID. After receipt of request letter from vendor, relevant documents for assessment purpose are sought by POWERGRID.
- b) If documents are found in order, an assessment committee visits the vendor works for verification of documents and assessment of manufacturing/testing facilities etc. on payment of assessment charges, wherever applicable.
- c) During visit, manufacturing facilities, testing facility, statutory requirements including BIS license (IS 1786), traceability, infrastructure, safety and quality aspects, credentials of past supply etc. are verified / assessed.
- d) Based on assessment, vendor is approved or rejected or shortcomings are conveyed to vendor for compliance. If the shortcomings are complied with, within given time frame, vendor is approved, initially for One year, and thereafter renewal is accorded based on supply performance.
