from DoT, when PGCIL withdrew bandwidth from a customer because it was detected to be a non licensed player OR because it was found to be sub leasing bandwidth to non licensed player. I do not have information as to which of the two was the reason. The reason may be informed to me together with a copy of the bandwidth withdrawal order/bandwidth agreement termination letter or whatever communication PGCIL used to intimate to the customer the decision and the reason for the withdrawal of bandwidth.

- 3. I may also be informed how this one incident was detected. If the detection was through the interaction with the ISPs, I may be provided minutes of this interaction. If the detection was through a written complaint, I may be kindly provided a copy of the complaint.
- 4. When PGCIL detected the said one incident of unauthorised use, it withdrew the bandwidth (vide Point 2 above) like a responsible licensee. However the particular user may have been running business unauthorisedly for the considerable period of time. For the earnings of the period, it owes License fee to the department. In this context I may be informed whether PGCIL intimated the incident to DoT. If yes, a copy of the intimation letter may be provided. If no, reasons thereof may be shared please.
