2. Reasons, in brief, for stopping entire pay & allowances.
3. Copies of rules with regard to stopping of pay & allowances.
4. Whether pay & allowances can be stopped without following the due procedure as laid down under CDA rules.
5. Whether pay & allowances can be stopped without proving the charges/misconduct.
6. Whether pay & allowances can be stopped without passing orders by Disciplinary Authority.
7. As per rules, what is the procedure followed/adopted to stop pay & allowances.


