On 1st July 2017 GST was implemented across the country replacing the then prevailing regime of indirect taxes.

Subsequent to the imposition of GST, Power Grid Corporation of India Ltd. had issued letter no. CC/CS/GST dated 06.10.2017 clarifying the detailed procedure to be followed for restructuring of contracts/bidding document due to implementation of GST.

- ii. A copy of the opinion sought by PGCIL from the GST Council/Ministry of Finance/any other entity in GoI for finalizing the above process and the response received therein.

Please send this information within 30 days as per Section 19(1) of RTI Act, 2005 to me at the following address:-




